RESOLUTION NO. 003 – 2021

RESOLUTION EARNESTLY REQUESTING THE NATIONAL GOVERNMENT THRU THE DEPARTMENT OF BUDGET AND MANAGEMENT MANILA TO PROVIDE THE CITY OF ROXAS A MULTIPURPOSE VEHICLE/MOBILE CLINIC VEHICLE WITH EQUIPMENT FOR COVID-19 TESTING AND OTHER MEDICAL DEVICES.

WHEREAS, it has been a year ago that our country has been battling (COVID-19) a global Pandemic due to the widespread infection across multiple countries; and recently a new strain of corona virus has reached the country and poses a threat to the young children who are most likely to be affected;

WHEREAS, as we continue to mitigate the effects of the Covid-19 Pandemic in the City, the present issuance are not sufficient to address the immediate health care concerns; and that although vaccine is the ultimate solution to this crisis, prevention will always be the best approach for the time being;

WHEREAS, Local Budget Circular No. 131 dated January 08, 2021 of the Department of Budget and Management has set guidelines on the release and utilization of the Local Government Support fund- Other Financial Assistance to Local Government Units in the Fiscal Year 2021 General Appropriations Act, Republic Act No. 11518;

WHEREAS, the issuance of this Circular prescribes guidelines and procedures on the release and utilization of the Local Government Support Fund and Financial Assistance to LGU's consistent with the Fiscal Year 2021 General Appropriations Acts;

NOW, THEREFORE, on motion presented by Hon. Trina Marie A. Ignacio, duly seconded by Hon. Cesar S. Yap, Jr., it is

RESOLVED, To request, as this Body earnestly requesting the Department of Budget and Management, thru Hon. Secretary Wendel E. Avisado to provide the City of Roxas a Multipurpose Vehicle/Mobile Clinic Vehicle with equipment for Covid-19 testing and other Medical devices to strengthen the existing mechanism of the City of Roxas in battling agasint Covid-19 Pandemic.
