RESOLUTION NO. 020 – 2021

A RESOLUTION AUTHORIZING HON. RONNIE T. DADIVAS, CITY MAYOR TO ENTER AND SIGN FOR AND IN BEHALF OF THE CITY OF ROXAS THE MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL HOUSING AUTHORITY (NHA), RELATIVE TO THE TURNOVER OF JUMAGUICJIC VILLE PHASE I AND II HOUSING PROJECT IN ROXAS CITY.

WHEREAS, the National Housing Authority (NHA) implemented the development of Jumaguicguic Villa Subdivision located in Brgy. Jumaguicguic, Roxas City, a permanent project for families affected by Tropical Storm (TS) Yolanda and those families living in danger areas and no-build zones;

WHEREAS, pursuant to NHA Board Resolution No. 6274 dated 29 November 2019, a full grant policy has been approved in the disposition of developed lots with housing units under the NHA Permanent Resettlement Program for qualified families/household affected by Typhoon Yolanda;

WHEREAS, there is a need to transfer the completed projects to the City Government of Roxas, including the award, transfer/relocation and cause the occupancy of the units to the beneficiaries to enable said government unit to administer, operate, maintain the completed components and utilize, maintain and/or improve the same in accordance with its function and responsibilities pertaining to such facilities;

WHEREAS, pursuant to Board Resolution No. 4115 dated May 27, 1999, the NHA General Manager was authorized to transfer/donate completed project components falling under the operation/maintenance of other agencies;

WHEREAS, the August Body deemed it necessary to authorize and sign the Memorandum of Agreement and Deed of Donation and Acceptance of Jumaguicguic Ville Phase I and II located in Barangay Jumaguicguic, Roxas City.


NOW THEREFORE on motion presented by Hon. Trina Marie A. Ignacio, duly seconded by Hon. Paul Ivan R. Baticados; it was

RESOLVED, as it is hereby resolved, to authorize Hon. Ronnie T. Dadivas, City Mayor, to enter and sign for and in behalf of the City of Roxas the Memorandum of Agreement (MOA) with the National Housing Authority (NHA), relative to the turnover of Jumaguicguic Ville Phase I and II Housing Project in Roxas City. 9


