RESOLUTION NO. 022 – 2021

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, RONNIE T. DADIVAS, TO SIGN FOR AND IN BEHALF OF THE CITY OF ROXAS, THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE – REGIONAL FIELD OFFICE VI (DA-RFO VI), REPRESENTED BY ENGR. REMELYN R. RECOTER, REGIONAL EXECUTIVE DIRECTOR, RELATIVE TO THE IMPLEMENTATION OF HIGH VALUE CROPS DEVELOPMENT PROGRAM.

**WHEREAS**, in his letter dated March 15, 2021, the City Mayor requested for the passage of a resolution authorizing him to sign, for and in behalf of the City of Roxas, the Memorandum of Agreement (MOA) with the Department of Agriculture-Regional Field Office VI (DA-RFO-VI), relative to the implementation of High Value Crops Development Program;

**WHEREAS**, the DFA-RFO VI aims to strengthen the Agriculture Sector through modernization, greater participation among Local Government Units, Farmers Organizations and people empowerment;

**WHEREAS**, the Local Government Unit is an active partner of the Department of Agriculture in the implementation and Dissemination of its programs and projects;

**WHEREAS**, the Department of Agriculture is mandated to facilitate the implementation of agricultural program/projects in the region through the provision of logistical, administrative and technical support in line with the needs and priorities of the Local Government Units and Farmers Association;

**WHEREAS**, Section 455(1)(vi) of the Local Government Code of 1991, provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and, such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;


**WHEREAS**, Section 33 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 expressly grants the local government units the power to cooperate with one another, consolidate their efforts and coordinate their activities for any legal purpose that is beneficial to them.

**NOW THEREFORE**, on motion presented by Hon. Paul Ivan R. Baticados, jointly seconded by Hon. Midelo D. Ocampo and Hon. Cesar S. Yap, Jr., it was
