RESOLUTION APPROVING THE ANNUAL BUDGET OF THE DIFFERENT BARANGAYS IN THE CITY OF ROXAS, FOR THE FISCAL YEAR 2021, IN THE TOTAL AMOUNT OF THIRTEEN MILLION TWO HUNDRED THIRTY SIX THOUSAND SIX HUNDRED SEVENTY PESOS (P13,236,670.00).

WHEREAS, in his 1<sup>st</sup> Indorsement dated April 12, 2021, the OIC - City Budget Officer submitted for review the Annual Budget of the different Barangays in the City of Roxas, for Fiscal Year 2021;

WHEREAS, Article 99 (1) of the Implementing Rules and Regulations of the Local Government Code of 1991 mandates the Sangguniang Panlungsod to review all ordinances approved by the Sangguniang Barangays.

WHEREAS, this Honorable Body, after preliminary review of the City Budget Officer and upon recommendation of the Committee on Barangay Affairs, found that the Annual Budgets of the different Barangays have substantially complied with the requirements of the law, implementing circulars and other issuances.

NOW, THEREFORE, on motion presented by Hon. Virgilio Santos, Jr., jointly seconded by Hon. Midelo D. Ocampo and Hon. Cesar S. Yap, Jr., it was
