AN ORDINANCE ABOLISHING THE VACANT POSITION OF TWO (2) METRO AIDE I, SALARY GRADE 2, ITEM NOS. 10 AND 22, STEP 1, IN THE CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE, CITY OF ROXAS.

WHEREAS, Article 164, Rule XXII of the Implementing Rules and Regulation of the Local Government Code of 1991 provides that a Local Government Unit may reorganize through the Sanggunian its present organizational structure or alter its present staffing pattern x x x

WHEREAS, the said position was vacant (deferred) in the Annual Budget Appropriation of 2021;

WHEREAS, after thorough study and deliberation this Honorable Body find the request meritorious and deemed it a necessary act;


NOW THEREFORE, be it ordained by the Sangguniang Panlungsod, in session assembled and by authority of the same, that



Unanimously Approved.


