## ORDINANCE NO. 004-2021

AN ORDINANCE CREATING THE POSITION OF ONE (1) PARK MAINTENANCE FOREMAN, SALARY GRADE 8, STEP 1, IN THE CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE AND APPROPRIATING FUNDS THERETO.

WHEREAS, in his letter dated January 7, 2021, the City Mayor requested to create the position of one (1) Park Maintenance Foreman, Salary Grade 8, Step 1, in the City Environment and Natural Resources Office and to appropriate funds thereto;

WHEREAS, the position is intended for the hands-on maintenance and supervision of a competent and skilled personnel who is familiar and well-oriented in the aspect of plant care maintenance and propagation to ensure smooth work operation;

WHEREAS, Articles 3, Section 458 of the Local Government Code of 1991 provides that the Sangguniang Panlungsod as a legislative body of the city, shall (vii) subject to the provisions of this code and pertinent laws, determine the power and duties of officials and employees of the city; (viii) determine the position and salaries, wages, allowances, and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government;

WHEREAS, the creation of one (1) City Environment and Natural Resources Office, Salary Grade 8, Step 1 is deemed necessary in order that the existing vital programs and projects can be effectively managed and maintained with quality result;

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod, in session assembled and by authority of the same, that:

Section 1 - To create, as this Honorable Body hereby creates, the position of one (1) Park Maintenance Foreman, Salary Grade 8, Step 1, in the City Environment and Natural Resources Office and to 9 appropriate funds thereto.

Section 2. – The amount of Two Hundred Ninety One Thousand Seven Hundred Seventy Three Pesos (P291,773.00), be appropriated to cover salary and other allowances/benefits of the said position.

Section 3. - This Ordinance shall take effect upon approval.
