AN ORDINANCE AUTHORIZING HON. RONNIE T. DADIVAS, CITY MAYOR, TO AUGMENT THE APPROPRIATION AMOUNTING TO NINETY TWO THOUSAND FIVE HUNDRED FORTY FOUR PESOS (P 92,544.00) TO BE TAKEN FROM SALARIES/WAGES – REGULAR AND PERSONAL ECONOMIC AND RELIEF ALLOWANCE (PERA) IN THE CITY DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (DRRMO) TO OVERTIME AND NIGHT PAY OF THE SAID OFFICE, PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, in his letter dated April 13, 2021, the City Mayor, forwarded the request of Mr. Dennis A. Saneo, LDRRMO IV, for augmentation of the amount of Ninety Two Thousand Five Hundred Forty Four Pesos (P92,544.00) to be taken from Salaries/Wages – Regular and PERA in the City Disaster Risk Reduction and Management Office (DRRMO) to Overtime and Night Pay of the said office, pursuant to Section 336 of the Local Government Code of 1991;

WHEREAS, Articles 454 (b), Rules XXXVI of the Implementing Rules and Regulation of R.A. 7160 provides the “ x x x “ the Local Chief Executive and Presiding Officer of the Sangguniang concerned, may by Ordinance, be authorized to augment any item in the approved Annual Budget for their respective Office from savings in other items within the same expense class of their respective appropriation, x x x

Section 1. - The Honorable City Mayor is hereby authorized to augment the appropriation of the amount of Ninety Two Thousand Five Hundred Forty Four Pesos (P92,544.00), to be taken from Salaries/Wages – Regular and PERA in the City Disaster Risk Reduction and Management Office (DRRMO) to Overtime and Night Pay of the said office, pursuant to Section 336 of the Local Government Code of 1991, viz:


