AN ORDINANCE TEMPORARILY CLOSING VARIOUS STREETS IN THE CITY OF ROXAS, FOR THE HOLDING OF THE BESTOWAL OF RED HAT AND THANKSGIVING MASS OF HIS EMINENCE, CARDINAL JOSE F. ADVINCULA ON MAY 28, 2021 FROM 7:00 A.M. TO 11:30 A.M.

WHEREAS, in his 1st Indorsement dated April 13, 2021, the City Mayor requested for the temporary closure of various streets in the City of Roxas, for the Holding of the Bestowal of Red Hat and Thanksgiving Mass of his Eminence, Cardinal Jose F. Advincula at Immaculate Concepcion Metropolitan Cathedral;

WHEREAS, various activities are lined-up for the visitors to witness and reflect;

WHEREAS, temporary closure of street is necessary to ensure not only the success of the said activity but also the safety of the people.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod, in session assembled and by authority of the same, that

Section 1. - ROAD SUBJECT TO TEMPORARY CLOSURE:

May 28, 2021 - Entire Public Plaza from corner Rizal-Hughes Street to corner Magallanes Street
Taft Street, front of Provincial Capitol up to the portion in between Rizal
Monument – Fountain – Tourism Office

Right and left side of Public Plaza portion and right side facing west Arsobispo Street portion will be utilized as parking area.
