TO CALGU OF THE SAID OFFICE, PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, in the request of Hon. Virgilio A. Santos, Jr. for augmentation of the amount of Thirty Five Thousand Pesos (P 35,000.00), to be taken from Travelling and Training Expenses of his Office to CALGU of the said office, pursuant to Section 336 of the Local Government Code of 1991;
