ORDINANCE NO. 022 - 2021

AN ORDINANCE PROVIDING FOR SCHEDULE OF FEES FOR THE ROXAS CITY ECONOMIC ENTERPRISE BUILDING

Sponsored By: Paul Ivan R. Baticados  
Jointly Seconded By: Cesar S. Yap, Jr. and Hon. Corazon B. Tiangco

**WHEREAS**, Chapter 2, Section 18 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the Local Government Units shall have the power and authority to create their own sources of revenues and to levy taxes, fees, and charges which shall accrue exclusively for their use and disposition and which shall be retained by them;

**WHEREAS**, Section 129, Book II, Title I, Chapter I of RA 7160 states that each local government unit shall exercise its power to create its own sources of revenue and to levy taxes, fees, and charges subject to the provisions herein, consistent with the basic policy of local autonomy. Such taxes, fees, and charges shall accrue exclusively to the local government units;

**WHEREAS**, Section 154, Book II, Title I, Chapter II of RA 7160, also provides that Local government units may fix the rates for the operation of public utilities owned, operated, and maintained by them within their jurisdiction;

**WHEREAS**, the City of Roxas has an Economic Enterprise Building located at Taft St., Roxas City which can be used for private and/or government offices for trade and business;

**WHEREAS**, the City of Roxas deemed it necessary to provide a schedule of fees for the Roxas City Enterprise Building to cover the cost of improvement, repair, and other related expenses of the said building.

**NOW, THEREFORE**, be it ordained by the Sangguniang Panlungsod that:

**SECTION I.** The following are the corresponding Monthly Rental Rate for the Roxas City Economic Enterprise Building:

Category	Monthly Rental Rate
Ground Floor	Php 500.00 per sq. m.
Second (2 <sup>nd</sup> ) Floor	Php 450 per sq. m.
Third (3 <sup>rd</sup> ) Floor	Php 350 per sq. m


**SECTION II.** The schedule of fees shall be subject to review of the Sangguniang Panlungsod every three (3) years.


