AN ORDINANCE AUTHORIZING HON. ERWIN B. SICAD, VICE MAYOR, TO AUGMENT THE APPROPRIATION AMOUNTING TO TWO HUNDRED TEN THOUSAND PESOS (P210,000.00), TO BE TAKEN FROM TRAVELLING AND TRAINING EXPENSES IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD TO CALGU OF THE SAID OFFICE, PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Hon. Erwin B. Sicad, Vice Mayor requested for augmentation of the amount of Two Hundred Ten Thousand Pesos (P210,000.00), to be taken from Travelling and Training Expenses in the Office of the Sangguniang Panlungsod to CALGU of the said office, pursuant to Section 336 of the Local Government Code of 1991;

WHEREAS, Articles 454 (b), Rules XXXVI of the Implementing Rules and Regulation of R.A. 7160 provides the "x x x" the Local Chief Executive and Presiding Officer of the Sangguniang concerned, may by Ordinance, be authorized to augment any item in the approved annual budget for their respective Office from savings in other items within the same expense class of their respective appropriation, x x x
