AN ORDINANCE AUTHORIZING HON. ERWIN B. SICAD, VICE MAYOR, TO AUGMENT THE APPROPRIATION AMOUNTING TO THIRTY THOUSAND PESOS (P30,000.00), TO BE TAKEN FROM TELEPHONE EXPENSES IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD TO REPAIR AND MAINTENANCE – TRANSPORTATION EQUIPMENT OF THE SAID OFFICE, PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Hon. Erwin B. Sicad requested for augmentation in the amount of Thirty Thousand Pesos (P 30,000.00), to be taken from Telephone Expenses in the Office of the Sangguniang Panlungsod to Repair and Maintenance – Transpiration Equipment of the said office, pursuant to Section 336 of the Local Government Code of 1991;

WHEREAS, Articles 454 (b), Rules XXXVI of the Implementing Rules and Regulation of R.A. 7160 provides the "x x x "the Local Chief Executive and Presiding Officer of the Sangguniang concerned, may by Ordinance, be authorized to augment any item in the approved annual budget for their respective Office from savings in other items within the same expense class of their respective appropriation, x x x

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod, in session assembled and by authority of the same, that:

Section 1. - The Honorable Vice Mayor is hereby authorized to augment the appropriation of the amount of Thirty Thousand Pesos (P30,000.00), to be taken from Telephone Expenses in the Office of the Sangguniang Panlungsod to Repair and Maintenance – Transportation Equipment of the said office, pursuant to Section 336 of the Local Government Code of 1991.
