ORDINANCE NO. 036-2021

AN ORDINANCE REPEALING ORDINANCE NO.002 - 2020 ENTITLED, 'AN ORDINANCE AMENDING SECTION 12, CHAPTER V OF ORDINANCE NO. 058-2011, OTHERWISE KNOWN AS THE "ROXAS CITY EXPANDED INVESTMENT INCENTIVES CODE".

WHEREAS, Section 12: Investment Priority Areas of Chapter V of the Roxas City Expanded Investment Incentives Code, was amended on 28 January 2020 through Ordinance No. 002-2020 by excluding malls among investment priority areas eligible for incentives;

WHEREAS, SM Supermalls - SM Prime Holdings, Inc., in a letter dated 31 May 2021 requested for the re-inclusion of malls among investment priority areas eligible for incentives granted under Section 18, 19 and 20 of the Roxas City Expanded Investment Incentives Code;

WHEREAS, due to the long-term economic return and value of said investment to the City of Roxas, the Roxas City Investment and Incentives Board grants the request of SM Supermalls - SM Prime Holdings Inc. through Board Resolution No. 001-2021 entitled: "RESOLUTION TO REINCLUDE MALLS AMONG THE INVESTMENT PRIORITY AREAS ELIGIBLE FOR INCENTIVES UNDER THE ROXAS CITY EXPANDED INVESTMENT INCENTIVES CODE";

WHEREAS, after careful thought and deliberation, this Sanggunian is convinced that the said investment will create positive and far-reaching effects not only to the economy but also to the people of Roxas City, such that this Sanggunian believes that it is timely and proper to reinclude malls as among the Investment Priority Areas

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Roxas, in session assembled and by authority of the same that:

Section 1 – To approve, as the Honorable Body hereby approves, to repeal Ordinance No. 002-2020 entitled, "an Ordinance amending Section 12, Chapter V of Ordinance No. 058-2011, otherwise known the "Roxas City Expanded Investment Incentives Code".

Section 2. - This Ordinance shall take effect upon approval.
