AN ORDINANCE AUTHORIZING HON. RONNIE T. DADIVAS, CITY MAYOR, TO AUGMENT THE APPROPRIATION AMOUNTING TO SEVENTY FIVE THOUSAND ONE HUNDRED FIFTY ONE PESOS & 70/100 (P75,151.70), TO BE TAKEN FROM PERSONAL SERVICES - SALARIES/WAGES – REGULAR IN THE CITY CIVIL REGISTRAR’S OFFICE TO OTHER PERSONNEL BENEFITS (MONETIZATION OF LEAVE CREDITS) OF THE SAID OFFICE, PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, in his letter dated August 03, 2021, the City Mayor, forwarded the request of Ms. Marilyn G. Albaran, City Civil Registrar, for augmentation in the amount of Seventy Five Thousand One Hundred Fifty One Pesos & 70/100 (P75,151.70), to be taken from Personal Services - Salaries/Wages – Regular in the City Civil Registrar’s Office to Other Personnel Benefits (Monetization of Leave Credits) of the said office, pursuant to Section 336 of the Local Government Code of 1991;

WHEREAS, Articles 454 (b), Rules XXXVI of the Implementing Rules and Regulation of R.A. 7160 provides the “ x x x “ the Local Chief Executive and Presiding Officer of the Sangguniang concerned, may by Ordinance, be authorized to augment any item in the approved annual budget for their respective Office from savings in other items within the same expense class of their respective appropriation, x x x

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod, in session assembled and by authority of the same, that:

Section 1. - The Honorable City Mayor is hereby authorized to augment the appropriation of Seventy Five Thousand One Hundred Fifty One Pesos & 70/100 (P75,151.70), to be taken from Personal Services - Salaries and Wages - Regular in the City Civil Registrar’s Office to Other Personnel Benefits (Monetization of Leave Credits) of the said office, pursuant to Section 336 of the Local Government Code of 1991.

Section 2. – This Ordinance shall take effect upon approval.


