AN ORDINANCE AUTHORIZING HON. RONNIE T. DADIVAS, CITY MAYOR, TO AUGMENT THE APPROPRIATION AMOUNTING TO ONE HUNDRED TWENTY THOUSAND PESOS (P120,000.00), TO BE TAKEN FROM PERSONAL SERVICES - SALARIES/WAGES - REGULAR IN THE OFFICE OF THE CITY ENGINEER TO OVERTIME AND NIGHT PAY OF THE SAID OFFICE, PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Engr. Noel I. Laminares, City Engineer, requested for augmentation in the amount of One Hundred Twenty Thousand Pesos (P120,000.00), to be taken from Personal Services - Salaries/Wages – Regular of his Office to Overtime and Night Pay of the said office, pursuant to Section 336 of the Local Government Code of 1991;
