ORDINANCE NO. 044 - 2021

AN ORDINANCE AUTHORIZING HON. RONNIE T. DADIVAS, CITY MAYOR, TO AUGMENT THE APPROPRIATION AMOUNTING TO ONE HUNDRED TWENTY THOUSAND PESOS (P120,000.00), TO BE TAKEN FROM PERSONAL SERVICES - SALARIES/WAGES – REGULAR IN THE OFFICE OF THE CITY ENGINEER TO OVERTIME AND NIGHT PAY OF THE SAID OFFICE, PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Engr. Noel I. Laminas, City Engineer, requested for augmentation in the amount of One Hundred Twenty Thousand Pesos (P120,000.00), to be taken from Personal Services - Salaries/Wages – Regular of his Office to Overtime and Night Pay of the said office, pursuant to Section 336 of the Local Government Code of 1991;

WHEREAS, Articles 454 (b), Rules XXXVI of the Implementing Rules and Regulation of R.A. 7160 provides the “ x x x “ the Local Chief Executive and Presiding Officer of the Sangguniang concerned, may by Ordinance, be authorized to augment any item in the approved annual budget for their respective Office from savings in other items within the same expense class of their respective appropriation, x x x

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod, in session assembled and by authority of the same, that:


Section 1. - The Honorable City Mayor is hereby authorized to augment the appropriation of One Hundred Twenty Thousand Pesos (P 120,000.00), to be taken from Personal Services - Salaries/Wages – Regular in the Office of the City Treasurer to Overtime and Night Pay of the said office, pursuant to Section 336 of the Local Government Code of 1991.

Section 2. – This Ordinance shall take effect upon approval.




