ORDINANCE NO. 046 - 2021

AN ORDINANCE AUTHORIZING HON. RONNIE T. DADIVAS, CITY MAYOR, TO AUGMENT THE APPROPRIATION AMOUNTING TO TWO HUNDRED SEVENTY SEVEN THOUSAND TWO HUNDRED EIGHTY TWO PESOS & 94/100 (P 277,282.94), TO BE TAKEN FROM PERSONAL SERVICES - SALARIES/WAGES - REGULAR IN THE CITY PLANNING AND DEVELOPMENT OFFICE TO OTHER PERSONNEL BENEFITS (MONETIZATION OF LEAVE CREDITS) OF THE SAID OFFICE, PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, in his letter dated August 25, 2021, the City Mayor, forwarded the request of Ms. Lorelei B. Piansay, City Planning and Development Coordinator, for augmentation in the amount of Two Hundred Seventy Seven Thousand Two Hundred Eighty Two Pesos & 94/100 (P 277,282.94), to be taken from Personal Services - Salaries/Wages - Regular in the City Planning and Development Office to Other Personnel Benefits (Monetization of Leave Credits) of the said office, pursuant to Section 336 of the Local Government Code of 1991;

WHEREAS, Articles 454 (b), Rules XXXVI of the Implementing Rules and Regulation of R.A. 7160 provides the "x x x" the Local Chief Executive and Presiding Officer of the Sangguniang concerned, may by Ordinance, be authorized to augment any item in the approved annual budget for their respective Office from savings in other items within the same expense class of their respective appropriation, x x x

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod, in session assembled and by authority of the same, that:

Section 1. - The Honorable City Mayor is hereby authorized to augment the appropriation of Two Hundred Seventy Seven Thousand Two Hundred Eighty Two Pesos & 94/100 (P 277,282.94), to be taken from Personal Services - Salaries/Wages - Regular in the City Planning and Development Office to Other Personnel Benefits (Monetization of Leave Credits) of the said office, pursuant to Section 336 of the Local Government Code of 1991.
