DADIVAS, CITY MAYOR, TO AUGMENT THE APPROPRIATION AMOUNTING TO THREE MILLION PESOS (P3,000,000.00), TO BE TAKEN FROM MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) UNDER THE EXECUTIVE DEPARTMENT (CITY MAYOR'S OFFICE – OTHER PURPOSES) TO MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) CITY ENGINEER'S OFFICE, PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, in his letter dated August 1, 2021, the City Mayor, requested for augmentation in the amount of Three Million Pesos (P3,000,000.00), to be taken from Maintenance and Other Operating Expenses (MOOE) under the Executive Department (City Mayor's Office – Other Purposes) to Maintenance and Other Operating Expenses (MOOE) – City Engineer's Office, pursuant to Section 336 of the Local Government Code of 1991;

WHEREAS, Articles 454 (b), Rules XXXVI of the Implementing Rules and Regulation of R.A. 7160 provides the " x x x " the Local Chief Executive and Presiding Officer of the Sangguniang concerned, may by Ordinance, be authorized to augment any item in the approved annual budget for their respective Offices from savings in other items within the same expense class of their respective appropriation, x x x


