SICAD, VICE MAYOR, TO AUGMENT THE APPROPRIATION AMOUNTING TO SIXTY NINE THOUSAND TWO HUNDRED PESOS (P69,200.00), TO BE TAKEN FROM TRAVELLING AND TRAINING EXPENSES AND GENERAL SERVICE/PROFESSIONAL SERVICE IN THE OFFICE OF HON. ALBERT GREGORY Y. POTATO TO CALGU, OFFICE SUPPLIES EXPENSES AND OM & OE – F/A TO JOB ORDER (ORDER/CONTRACT OF SERVICE EMPLOYEES) OF THE SAID OFFICE, PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991.






