TIANGCO TO CALGU, OM & OE – F/A TO JOB ORDER (CONTRACT OF SERVICE EMPLOYEES) AND OFFICE SUPPLIES EXPENSES OF THE SAID OFFICE, PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991.


