ROBERTO V. IGNACIO TO CALGU AND OM & OE – F/A TO JOB ORDER (CONTRACT OF SERVICE EMPLOYEES) OF THE SAID OFFICE, PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Hon. Roberto V.
