AN ORDINANCE AUTHORIZING HON. ERWIN B. JERICHO ANGEL L. CELINO TO CALGU OF THE SAID OFFICE, PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991.
