Section 1 - To abolish, as the Honorable Body hereby abolishes, the vacant positions of one (1) Administrative Aide VI (Clerk III), Salary Grade 6/1, Item No. 35, one (1) Senior Administrative Assistant I (DEMO IV), Salary Grade 13/1, Item No. 49 and one (1) Agenda/Minutes Officer III, Salary Grade 15/1, Item No. 46 in the Office of the Sangguniang Panlungsod, City of Roxas.


