AN ORDINANCE CREATING THE POSITIONS OF ONE (1) ADMINISTRATIVE AIDE VI (UTILITY FOREMAN), SALARY GRADE 6/1, ITEM NO. 66, ONE (1) ADMINISTRATIVE AIDE III (UTILITY WORKER II) SALARY GRADE 3/1, ITEM NO. 67, ONE (1) ADMINISTRATIVE AIDE IV (BOOKBINDER II), SALARY GRADE 4/1, ITEM NO. 68 AND ONE (1) ADMINISTRATIVE ASSISTANT I (BOOKBINDER III), SALARY GRADE 7/1, ITEM NO. 69 IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD AND APPROPRIATING FUNDS THERETO.

WHEREAS, in his letter dated November 10, 2021, the Vice Mayor requested to create the positions of one (1) Administrative Aide VI, (Utility Foreman), Salary Grade 6/1, Item No. 66, one (1) Administrative Aide III (Utility Worker II), Salary Grade 3/1, Item No. 67, One (1) Administrative Aide IV (Bookbinder II), Salary Grade 4/1, Item No. 68 and One (1) Administrative Assistant I (Bookbinder III), Salary Grade 7/1, Item No. 69 in the Office of the Sangguniang Panlungsod and to appropriate funds thereto;

WHEREAS, Articles 3, Section 458 of the Local Government Code of 1991 provides that the Sangguniang Panlungsod as a legislative body of the city, shall (vii) subject to the provisions of this code and pertinent laws, determine the power and duties of officials and employees of the city; (viii) determine the position and salaries, wages, allowances, and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government;

WHEREAS, the creation of the said positions is deemed necessary in order that the existing vital programs and projects can be effectively managed and maintained with quality result;

WHEREAS, there is a need to appropriate funds for this position in order for it to be filled up considering the necessity of the said positions in the operation of the Office of the Sangguniang Panlungsod;

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod, in session assembled an by authority of the same, that:

Section 1 - To create, as this Honorable Body hereby creates, the positions of one (1) Administrative Aide VI, (Utility Foreman), Salary Grade 6/1, Item No. 66, one (1) Administrative Aide III (Utility Worker II), Salary Grade 3/1, Item No. 67, One (1) Administrative Aide IV (Bookbinder II), Salary Grade 4/1, Item No. 68 and One (1) Administrative Assistant I (Bookbinder III), Salary Grade 7/1, Item No. 69 in the Office of the Sangguniang Panlungsod and to appropriate funds thereto;
