ORDINANCE NO. 080 - 2021

AN ORDINANCE FURTHER AMENDING SECTION 2 OF ORDINANCE NO. 019-2020, OTHERWISE KNOWN AS "AN ORDINANCE TEMPORARILY PROVIDING RESTRICTIONS IN THE OPERATION OF TRICYCLES FOR HIRE IN THE CITY OF ROXAS BY DEVISING A NUMBER CODING SCHEME AND LIMITING THE NUMBER OF PASSENGERS ALLOWED AND OTHER PROVISIONS TO ENSURE PHYSICAL DISTANCING AND MANDATORY WEARING OF FACE MASK, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF", AS AMENDED BY ORDINANCE NO. 028-2020."

SECTION 1. Section 2 of Ordinance No. 019-2020 which reads as:

Section 2. ODD-EVEN NUMBER CODING SCHEME. - Tricycles for hire are allowed to operate within the territorial jurisdiction of the City of Roxas on specific schedules per day by **an "Odd-Even" Number Coding Scheme** based on the ending or last digit of their city numbers, during the period beyond curfew hours under the Provincial Governor's Executive Order (E.O.) No. 16, Series of 2020 or any other executive orders, laws and ordinances that maybe issued subsequent to the said E.O. No. 16, applicable within the territorial jurisdiction of the City of Roxas, as follows:

<u>DAYS OF THE WEEK</u>	<u>LAST DIGIT OF CITY NUMBER</u>
Mondays-Wednesdays-Fridays	1-3-5-7-9 (Odd numbers)
Tuesdays-Thursdays-Saturdays	2-4-6-8-0 (Even Numbers)
Sundays	All odd and even numbers

In the case of a tricycle which is not scheduled to operate for the particular day, it may be allowed to operate on the streets provided, it is for personal, private or family use; in which case, the driver/operator shall place a large readable poster or signage outside the sidecar stating: **"FOR PRIVATE USE" or "FOR FAMILY USE" ONLY** before going out on the streets or highways. The driver/operator shall also do the same even if he is scheduled to operate based on the number coding if his tricycle is carrying his immediate member of the family and is considered for private use for the moment.

Is hereby amended to read as follows:

Section 2. MODIFIED NUMBER CODING SCHEME. - Tricycles for hire are allowed to operate within the territorial jurisdiction of the City of Roxas everyday except on the following days, based on the ending or last digit of their city numbers under a “modified number coding scheme”, as follows:

<u>DAYS OF THE WEEK</u>	<u>LAST DIGIT OF CITY NUMBER</u>
Monday	1-2-3
Tuesday	4-5-6
Wednesday	7-8-9-0
Thursday	1-2-3
Friday	4-5-6
Saturday	7-8-9-0

Section 2-A. EXEMPTIONS - This Modified Number Coding Scheme is not implemented on the following occasions/instances:


1. Sundays and holidays;
2. Tricycles carrying person/s needing immediate medical attention, or is being used for emergency purpose;
3. Strictly for private or family use only. In which case, the driver/operator shall place a large readable poster or signage outside the sidecar stating “FOR PRIVATE USE” or FOR FAMILY USE ONLY” before going out on the streets or highway. PROVIDED, that if the said driver/operator is caught cheating or abusing this exemption by actually conveying passengers for hire, he shall be imposed with double the penalty provided under Ordinance No.019-2020 for the first and second offenses, and the maximum penalty of Five Thousand Pesos (₱5,000.00) for the third and subsequent offenses;

Section 3. EFFECTIVITY . - This ordinance shall take effect immediately the following Monday after its approval
