ORDINANCE NO. 086 - 2021

AN ORDINANCE CREATING VARIOUS POSITIONS IN THE OFFICE OF THE CITY BUDGET OFFICE AND APPROPRIATING FUNDS THERETO.

WHEREAS, in the Proposed 2021 Annual Budget the City Mayor recommended the creation of the various position in the Office of the City Budget and to appropriate funds thereto;

WHEREAS, Articles 3, Section 458 of the Local Government Code of 1991 provides that the Sangguniang Panlungsod as a legislative body of the city, shall (vi) subject to the provisions of this code and pertinent laws, determine the power and duties of officials and employees of the city; (viii) determine the position and salaries, wages, allowances, and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government;

WHEREAS, the creation of various positions in the Office of the City Budget are deemed necessary in order that the existing vital programs and projects can be effectively managed and maintained with quality results.

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod, in session assembled and by authority of the same, that:

Section 1 - To create, as this Honorable Body hereby creates, the following positions:

1. One (1) Administrative Officer V (Budget Officer III), Salary Grade 18, Step 1, Item No. 03

Administrative Division

2. One (1) Senior Administrative Assistant I (Data Entry Machine Operator IV), Salary Grade 13, Step 1, Item No. 12
- One (1) Administrative Assistant VI, Salary Grade 10, Step 1, Item 13




- 3. One (1) Administrative Assistant IV (Bookbinder IV), Salary Grade 10, Step 1, Item No. 09

Section 2. - This Ordinance shall take effect upon approval.




