ORDINANCE NO. 089 - 2021

AN ORDINANCE TRANSFERRING THE POSITION OF ENGINEER I INCLUDING THE PERSONNEL SERVICE BUDGET FROM THE OFFICE OF THE CITY ENGINEER TO THE OFFICE OF THE CITY MAYOR - AGRICULTURE AND BIOSYSTEM ENGINEERING (ABE) UNIT AND THEREBY APPROVING THE NEW PLANTILLA STRUCTURE AS A RESULT OF THE TRANSFER.

WHEREAS, Section 76 of RA 7160, otherwise known as the Local Government Code of 1991 provides that "Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration the service requirements and financial capacity, subject to the minimum standards and guidelines prescribed by the Civil Service Commission";

WHEREAS, DA, DBM, CSC and DILG Joint Memorandum Circular No. 02, series of 2020 dated June 2q4, 2020, provides the implementing guidelines on the strengthening and establishment of the agricultural and biosystem engineering groups of the Local Government Units;

WHEREAS, after thorough discussion on the matter, the August Body deemed it proper to transfer the said position in order to have a personnel assigned and perform specific function of the said unit.

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod, in session assembled and by authority of the same, that:

Section 1 - To Transfer the position of Engineer I including personnel service budget from the Office of the City Engineer to the Office of the City Mayor and thereby approving the New Plantilla Structure as a result of the transfer.




