RESOLUTION NO. 001 – 2021

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, RONNIE T. DADIVAS, TO NEGOTIATE, ENTER INTO AND SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ROXAS, FOR THE PROCUREMENT, SUPPLY AND AVAILMENT OF COVID-19 VACCINES WITH ASTRA ZENECA (UK), PFIZER (US) AND OTHER VACCINE MANUFACTURERS IN ACCORDANCE WITH GUIDELINES AND PROCEDURES DETERMINED BY THE NATIONAL TASK FORCE AGAINST COVID-19 (NTF) AND APPROPRIATE AUTHORIZATIONS AND REGULATORY PROCESSES OF THE DEPARTMENT OF HEALTH (DOH).

WHEREAS, in his letter dated January 11, 2021 the City Mayor requested the authority to negotiate, enter into and sign for and in behalf of the City Government of Roxas, for the procurement, supply and availment of COVID-19 vaccines with AstraZeneca (UK), Pfizer (US) and other vaccine manufacturers;

WHEREAS, on March 10, 2020, the World Health organization (WHO) has considered and declared COVID-19 as a pandemic;

WHEREAS, Proclamation Nos. 922 (s. 2020) and 1021 (s. 2020) declared a state a public health emergency and extension of the state of calamity, respectively throughout the country due to the COVID-19 pandemic, and enjoined all government agencies to mobilize the necessary resources to undertake critical, urgent and appropriate response, measure to eliminate the COVID-19 threat;

WHEREAS, pursuant to Section 11, Article XIII of the 1987 Philippine Constitution, the state shall adopt an integrated and comprehensive approach to health development which shall endeavour to make essential goods, health and other social services available to all people at affordable cost;

WHEREAS, pursuant to Proclamation No. 929, Local Government Units are enjoined to mobilize necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the effects of the surge or occurrence of 2019 Novel Coronavirus Acute Respiratory Disease (COVID-19);

WHEREAS, pursuant to Republic Act No. 11494, or the “Bayanihan to Recover As One Act” was enacted authorizing the President to suppress the COVID-19 pandemic through the procurement of drugs and vaccines;

WHEREAS, Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential for general welfare;


NOW THEREFORE, on motion presented by Hon. Paul Ivan R. Baticados, jointly seconded by Hon. John Paul J. Arcenas and Hon. Midelo D. Ocampo, it was

RESOLVED: To authorize, as this Honorable Body hereby authorizes, the Honorable City Mayor, Ronnie T. Dadivas, to negotiate, enter into and sign for and in behalf of the City Government of Roxas, for the procurement, supply and availment of COVID-19 vaccines with ASTRAZENECA (UK), and PFIZER (US) and other vaccine manufacturers in accordance with guidelines and procedures determined by the National Task Force against COVID 19 (NTF) and appropriate authorizations and regulatory processes of the Department of Health (DOH).


