RESOLUTION ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THE PRIORITY PROJECTS OF THE ROXAS CITY GOVERNMENT FOR FUNDING PURPOSES UNDER THE TAX REFORM ACCELERATION AND INCLUSION (TRAIN) ACT.

WHEREAS, the Roxas City Government has identified the priority projects included in the Annual Investment Plan (AIP) for the year 2020-2021;

WHEREAS, these projects are intended for Infrastructure Development Program/Road Network Development, such as construction of roads and bridges, wharves and rehabilitation and improvement of the fish port; to wit:

- 1) Construction of Arnaldo Boulevard-Barangay Tanque Diversion Road with Bridge P118,000.00;
- 2) Construction of San Roque-Arnaldo Boulevard By-Pass Road P 77,173,070.40;
- 3) Construction of Brgy. Cagay-Pueblo de Panay By-Pass Road P84,470,194.65;
- 4) Construction of Barangay Milibili- Brgy. Bato-Brgy. Banica By Pass Road P86,898,902.20;
- 5) Construction of reinforced box type drainage P102,000,000.00;
