#### RESOLUTION NO. 007 - 2021

RESOLUTION SUPPORTING THE DEPARTMENT OF HEALTH INTERIM GUIDELINES IN THE IMPLEMENTATION OF "MR. POLIO SIA" (MEASLES RUBELLA AND POLIO SUPPLEMENTAL IMMUNIZATION) TO PREVENT RESURGENCE OF THESE HIGHLY CONTAGIOUS DISEASES"

WHEREAS, Section 17 (b)(2)(iii) of the Local Government Code of 1991 (R.A. 7160) provides that health and services, which include the implementation of programs and projects on primary health care, maternal and child care and communicable and non-communicable disease control be made available;

WHEREAS, Measles-Rubella Supplemental Immunization Activity (SIA) conducted in 2014 successfully prevented viral transmission, albeit insufficient to advance the country's progress towards total elimination;

WHEREAS, in 2017, there was a significant increase in measles incidence of 23.1 per million population in comparison to 6.2 in 2016;

WHEREAS, as new cohorts of children remain unprotected for the measles, rubella and polio viruses due to persistently low coverage, worsened by the COVID-19 Pandemic, a supplemental/periodic mass immunization is needed to increase population immunity;

WHEREAS, the active support, participation and commitment of all barangays are pivotal in the realization of the Municipal Immunization program to reduce childhood morbidity and mortality.

NOW, THEREFORE, on motion presented by Hon. Cesar S. Yap, duly seconded by Hon. Midelo D. Ocampo, it was, RESOLVED,

### SECTION 1. SENSE OF THE ROXAS CITY SANGGUNIANG PANLUNGSOD.

- A. The Sangguniang Panlungsod fully supports Department of Health's interim guidelines in the implementation of "MR POLIO SIA" (Measles Rubella and Polio Supplemental Immunization) to prevent resurgence of these highly contagious diseases
- B. The Sanggunian fully welcomes the likelihood of an Executive Order to guide and realize the guccess of this life-saving endeavor to wit:

- 1. COMPULSORY PARTICIPATION. All barangays are enjoined to actively participate in the implementation and monitoring of the MR. Polio SIA.
- 2. INTEGRATION. All barangays shall integrate their MR. Polio SIA Micro plan in their respective health program.
- 3. ALLOCATION OF FUND. All Barangays shall allocate funds to supplement the implementation of the campaign in their respective areas of responsibilities.
- 4. REPORT. A daily accomplishment/monitoring report by the barangay through the assigned RHM/ vaccination team shall be submitted to the RHU for consolidation.

### SECTION 2. EFFECTIVITY

This Resolution shall take effect immediately upon its approval.
