RESOLUTION APPROVING THE APPLICATION FOR A PRELIMINARY APPROVAL AND LOCATIONAL CLEARANCE AND FINAL APPROVAL AND DEVELOPMENT PERMIT OF MONTE VISTA, OWNED AND DEVELOPED BY PUEBLO DE PANAY INC., UNDER PD 957 OPEN MARKET ON LOT NOS. 1973-B-2-B, 1973-B-2-C AND 1973-B-5 WITH A TOTAL DEVELOPMENT AREA OF 103,160 SQ.M., LOCATED AT BARANGAY LAWA-AN, ROXAS CITY.
