RESOLUTION AUTHORIZING THE CITY MAYOR, TO CHARGE THE UNSETTLED HOSPITALS AND FUNERAL HOMES BILLS FOR 2020, TO THE 2021 ANNUAL EXECUTIVE BUDGET OF THE CITY MAYOR'S OFFICE – OTHER PURPOSES AND SENIOR CITIZEN FUND (EMERGENCY ASSISTANCE PROGRAM) AMOUNTING TO ONE MILLION FIVE HUNDRED SEVENTY SIX THOUSAND SIX HUNDRED EIGHTY SEVEN PESOS (P1,576,687.00).

NOW, THEREFORE, on motion presented by Hon. Trina Marie A. Ignacio, duly seconded by Hon. John Paul Arcenas, it was


