RESOLUTION NO. 014 - 2021

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, RONNIE T. DADIVAS, TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE CITY OF ROXAS THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH REGIONAL OFFICE VI (DOH RO VI), REPRESENTED BY DR. EMILIA P. MONICIMPO, DIRECTOR IV, DOH REGIONAL OFFICE VI, RELATIVE TO THE IMPLEMENTATION OF THE INTEGRATED HOSPITAL OPERATIONS AND MANAGEMENT INFORMATION SYSTEM (iHOMIS) AT THE ROXAS CITY DIAGNOSTIC AND LABORATORY CENTER.

WHEREAS, in his letter dated February 26, 2021, the City Mayor requested for the passage of a resolution authorizing him to enter and to sign for and in behalf of the City of Roxas, the Memorandum of Agreement with the Department of Health Regional Office VI (DOH RO VI), relative to the implementation of the Integrated Hospital Operations and Management Information System (IHOMIS) at the Roxas City Diagnostic and Laboratory Center;

WHEREAS, the Department of Health – Western Visayas Center for Health Development is the lead agency in the protection and promotion of the health of its citizens, particularly the marginalized and the poor, is tasked to subsidize government hospitals;

WHEREAS, the Philippine eHealth Strategic Framework and Plan 2014-2020 which provides direction and outlines measurable goals for the National eHealth program has the vision that by 2020, "An ICT-enabled Philippine Health System towards better and equitable access to quality health care services, and an easier access to secure real time and quality health data and information for evidenced-based decision making" is achieved;

WHEREAS, IHOMIS Software is a reference model for electronic medical records and hospital information within and among hospitals, fully utilizing hospital data for evidence based decision making and developing a computer software for program based on the DOH standards and the International Classification of Diseases;

WHEREAS, Section 455(1)(vi) of the Local Government Code of 1991, provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and, such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or A ordinance;

WHEREAS, Section 33 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 expressly grants the local government units the power to cooperate with one another, consolidate their efforts and coordinate their activities for any legal purpose that is beneficial to them;
