## RESOLUTION NO. 024 - 2021

RESOLUTION AMENDING RULE XI (F) OF RESOLUTION NO. 77-2016 OTHERWISE KNOWN AS THE "INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG PANLUNGSOD OF ROXAS CITY" TO INCLUDE "ANY MEMBER WHO MAY WISH TO AVAIL OF THE PRIVILEGE HOUR FOR THE PURPOSE OF PROPOSING LEGISLATIVE MEASURES, SHALL FURNISH A COPY THEREOF, TO EACH OF THE MEMBERS, INCLUDING THE SP SECRETARY, UNLESS THE PROPOSAL SHALL BE CONSIDERED AS URGENT BY A MAJORITY OF ALL THE MEMBERS OF THE SANGGUNIAN".

WHEREAS, experience has shown that every time a Member avails of the Privilege Hour, for the purpose and of proposing legislative measures, the Honorable Body, more often than not, was placed in a dilemma wherein the members were not furnished with advance copies of the proposed legislative measure;

WHEREAS, in order to check possible flaws, erroneous decisions on hastily passed resolutions and/or ordinances, the Committee on Rules and Ordinances has recommended for an amendment of Rule XI (f) of Resolution No. 77 series of 2016;

NOW THEREFORE, on motion presented by Hon. Paul Ivan R. Baticados, severally seconded by Hon. Jericho Angel L. Celino, Hon. Midelo D. Ocampo and Hon. Cesar S. Yap, Jr., it was
