RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, RONNIE T. DADIVAS, TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE CITY OF ROXAS THE MEMORANDUM OF AGREEMENT (MOA) IN FAVOR OF THE ROXAS CITY GOVERNMENT WITH JOLLIBEE GROUP FOUNDATION, INC., RELATIVE TO IT'S BUSOG, LUSOG, TALINO (BLT) SCHOOL FEEDING PROGRAM.

WHEREAS, in his letter dated March 22, 2021, the City Mayor requested for the passage of a resolution authorizing him to enter and to sign for and in behalf of the City of Roxas, the Memorandum of Agreement (MOA) in favor of Roxas City Government with Jollibee Group Foundation, Inc.;

WHEREAS, the Jollibee Group foundation has been contributing to the mitigation of hunger in schools since 2007 through its Busog, Lusog, Talino (BLT) School Feeding Program that is implemented together with Local Implementing Partners (LIP);

WHEREAS, the Local Government Unit (LGU) functioning as the Local Implementing Partner (LIP), implements nutrition-specific and nutrition-sensitive programs that cater to different age groups, specifically those from vulnerable groups;

WHEREAS, the parties concerned agree to share with one another their respective capabilities and resources to provide the necessary support to implement the Program as specified in the Agreement;

WHEREAS, Section 455(1)(vi) of the Local Government Code of 1991, provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and, such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or  $\,arrho$ ordinance;
