WHEREAS, Section 64 of the Implementing Rules and Regulations of the Local Government Code of 1991 empowers the Sanggunian concerned to accredit community based People's Organizations (POs) or Non-Government Organizations (NGOs), Private Sector Organizations (PSOs) including business and professional groups and other similar aggrupation's who apply and are qualified for membership in the local special bodies;

WHEREAS, the *GRF Hublag Microfinance Foundation Inc.*, has filed their application with the Honorable Body for accreditation for membership in the Local Special Bodies pursuant to the above-mentioned provisions of law;
