## RESOLUTION NO. 031 - 2021

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, RONNIE T. DADIVAS, TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE ROXAS CITY DIAGNOSTIC AND LABORATORY CENTER (RCDLC) THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH —WESTERN VISAYAS CENTER FOR HEALTH DEVELOPMENT (DOH-WV-CHD), REPRESENTED BY DIRECTOR IV EMILIA P. MONICIMPO, MD, MPH, CSEE, RELATIVE TO THE GRANT OF FINANCIAL ASSISTANCE AMOUNTING TO FIVE MILLION PESOS (P5,000,000.00) TO SUPPORT THE OPERATIONS OF THE ROXAS CITY DIAGNOSTIC AND LABORATORY CENTER (RCDLC).

WHEREAS, in his letter dated April 7, 2021, the City Mayor requested for the passage of a resolution authorizing him to enter and to sign for and in behalf of the Roxas City Diagnostic and Laboratory Center (RCDLC), the Memorandum Of Agreement with the Department of Health – Western Visayas Center for Health Development (DOH-WV-CHD), relative to the grant of financial assistance amounting to Five Million Pesos (P5,000,000.00) to support the operations of Roxas City Diagnostic and Laboratory Center (RCDLC);

**WHEREAS**, the Department of Health – Western Visayas Center for Health Development is the lead agency in the protection and promotion of the health of its citizens, particularly the marginalized and the poor, is tasked to subsidize government hospitals;

WHEREAS, to avoid further local transmission of COVID-19, President Rodrigo R. Duterte issued Proclamation No. 929 dated March 16, 2020 mandating all government agencies and LGUs to render full assistance and mobilize all the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the COVID threat;

WHEREAS, in response to the COVID-19 pandemic and under Republic Act No. 11494, also known as Bayanihan to Heal as One Act, financial assistance shall be provided to identified COVID-19 laboratories for expansion of testing capacities as localization of services;

WHEREAS, Section 455(1)(vi) of the Local Government Code of 1991, provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and, such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, Section 33 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 expressly grants the local government units the power to cooperate with one another, consolidate their efforts and coordinate their activities for any legal purpose that is beneficial to them.

NOW THEREFORE, on joint motion presented by Hon. Albert Gregory Y. Potato and Hon. Paul Ivan R. Baticados, duly seconded by Hon. Cesar S. Yap, Jr., it was
