RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, RONNIE T. DADIVAS, TO SIGN FOR AND IN BEHALF OF THE CITY OF ROXAS THE MEMORANDUM OF UNDERSTANDING (MOU), TO BE ENTERED INTO BY AND BETWEEN THE ROXAS CITY GOVERNMENT AND THE CAPIZ STATE UNIVERSITY (CAPSU), REPRESENTED BY ITS PRESIDENT, EDITHA C. ALFON, RELATIVE TO THE PROMOTION OF LITERACY, LOCAL HISTORY, CULTURE AND HERITAGE THROUGH RESOURCE SHARING, PARTNERSHIPS AND NETWORKING.

WHEREAS, in his letter dated April 7, 2021, the City Mayor requested for an authority to sign, for and in behalf of the City of Roxas, a Memorandum Of Understanding (MOU) with Capiz State University, relative to the promotion of literacy, local history, culture and heritage through resource sharing, partnerships and networking;

WHEREAS, the objective of this partnership is to advance the promotion of literacy, local history, culture, heritage and the love for country through resource sharing and partnership between the CAPSU libraries and the Roxas City Government through Ang Panublion Museum;

WHEREAS, subject to the existing policies and regulations of each institution, any agreement entered into by the parties concerned shall be based on fair and reasonable sharing of resources and partnerships and proper observance of the rules and regulations of each institution;

WHEREAS, Section 455 (I) (vi) of the Local Government Code of 1991, provides that the City Mayor shall represent the City in all business transaction and sign in, its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

NOW THEREFORE, on joint motion presented by Hon. Albert Gregory Y. Potato and Hon. Paul Ivan R. Baticados, duly seconded by Cesar S. Yap, Jr., it was
