ORDINANCE NO. 011 - 2023

AN ORDINANCE GRANTING FRANCHISE TO MR. FLORIAN FILAMER B. DIAZ, JR. TO OPERATE AND MAINTAIN A LICENSED COCKPIT AT BARANGAY DAYAO, ROXAS CITY.

WHEREAS, Mr. Florian Filamer B. Diaz, Jr. requested this August Body to grant him a franchise to operate and maintain a cockpit at Barangay Dayao, Roxas City;

WHEREAS, R.A. 7160, otherwise known as the Local Government Code of 1991, grants authority to the Sangguniang Panlungsod to authorize the establishment, operation and maintenance of cockpits within its territorial jurisdiction;

WHEREAS, after deliberation on the matter, this August Body deemed in order to grant Mr. Florian Filamer B. Diaz, Jr. a franchise to operate and maintain a licensed cockpit at Barangay Dayao, Roxas City subject to the provisions of City Ordinance No. 038-2008 and other applicable laws, rules and regulations.

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Roxas, that:

**SECTION 1. – Grant of Franchise:**

A Franchise is hereby granted to Mr. Florian Filamer B. Diaz, Jr. to operate and maintain a licensed cockpit at Barangay Dayao, Roxas City subject to the provisions of City Ordinance No. 038-2008 and other applicable laws, rules and regulations.

**SECTION 2. – Effectivity of Franchise:**

That the Franchise shall be effective for a period of Fifteen (15) years commencing from the date of approval and renewable for similar period subject to the approval of this August Body.

**SECTION 3. – Franchise Fee:**

Franchise Fee is fixed at Fifty Thousand Pesos (P50,000.00) excluding payments of business permits and other regulatory fees.

**SECTION 4. – Prohibition:**

That the Franchise is a privilege given to the Grantee, and as such, the Grantee is prohibited to sell, assign, lease, transfer or to enter to any transaction to any person, natural or juridical, that will assign or transfer any rights and privileges acquired thru this Ordinance without prior notice and approval from this August Body.

**SECTION 5. – Revocatory Provision:**

That the Franchise, including the complimenting business permit to operate, shall be revoked or cancelled upon showing of any non-compliance of the conditions set forth therein and for any violation of City Ordinance No. 038-2008 and other pertinent laws, ordinances, rules and regulations.

**SECTION 6. – Separability Clause:**

Should any provision of this Ordinance or any part thereof be declared invalid or unconstitutional, the remaining provisions not affected shall continue to be in full force and effect.

**SECTION 7. – Repealing Clause:**

All existing Ordinances, Resolutions, Rules and Regulations and other issuances inconsistent with the provisions and/or purposes of this Ordinance are hereby repealed, amended or modified accordingly.


**SECTION 8. – Effectivity:**


