ORDINANCE NO. 013 - 2023

AN ORDINANCE AUTHORIZING THE HONORABLE VICE MAYOR TO SIGN CONTRACTS ENTERED INTO BY THE SANGGUNIANG PANLUNGSOD WITH ENTITIES AND/OR INDIVIDUALS FOR THE PROVISION OF SPECIALIZED SERVICE AND IN THE HIRING OF VARIOUS CONTRACTUALS/JOB ORDER PERSONNEL FOR THE SANGGUNIANG PANLUNGSOD OF ROXAS CITY.

WHEREAS, Section 456 (a) (2) of the Local Government Code of 1991, provides that the Vice Mayor shall appoint all officials and employees of the Sangguniang Panlungsod, except those whose manner of appointment is specifically provided in this Code;

WHEREAS, in order to ensure proper documentation and promote transparency, Contracts entered into by the Sangguniang Panlungsod with entities and/or individuals for the provision of specialized service and in the hiring of various contractual/job order personnel for the Sangguniang Panlungsod of Roxas City must be signed by the City Vice Mayor.

NOW, THEREFORE, be it ORDAINED, as it is hereby Ordained by the Sangguniang Panlungsod, in session assembled that:

SECTION 1. **Authority of the Vice Mayor.** The Vice Mayor is authorized to sign contracts entered into by the Sangguniang Panlungsod with entities and/or individuals for the provision of specialized service and in hiring of various contractual/job order personnel for the Sangguniang Panlungsod of Roxas City.

SECTION 2. **Repealing Clause.** All ordinance, resolutions, local executive orders and/or administrative regulations which are inconsistent or contrary to any of the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 3. *Effectivity Clause.* This Ordinance shall take effect immediately upon its approval.
