AN ORDINANCE ABOLISHING THE VACANT POSITIONS OF THREE (3) ADMINISTRATIVE AIDE I, SALARY GRADE 1/1, ITEM NOS. 55, 57 & 65 IN THE GENERAL SERVICES OFFICE AND TWO (2) METRO AIDE, SALARY GRADE 2/1, ITEM NOS. 16 & 25 IN CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE, CITY OF ROXAS.

WHEREAS, in his letter dated April 28, 2023, the City Mayor requested for the abolition of the vacant positions of Three (3) Administrative Aide I, Salary Grade 1/1, Item Nos. 55, 57 & 65 in the General Services Office and Two (2) Metro Aide I, Salary Grade 2/1, Item Nos. 16 & 25 in the City Environment and Natural Resources Office, City of Roxas;

WHEREAS, Article 164, Rule XXII of the Implementing Rules and Regulation of the Local Government Code of 1991 provides that a Local Government Unit may reorganize through the Sanggunian its present organizational structure or alter its present staffing pattern x x x;

WHEREAS, the said positions were vacant in the Annual Budget Appropriation of 2023;

WHEREAS, after thorough study and deliberation this Honorable Body find the request meritorious and deemed it a necessary act.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod, in session assembled and by authority of the same, that

Section 1 – To abolish, as the Honorable Body hereby abolishes, the vacant positions Three (3) Administrative Aide I, Salary Grade 1/1, Item Nos. 55, 57 & 65 in the General Services Office and Two (2) Metro Aide I, Salary Grade 2/1, Item Nos. 16 & 25 in the City Environment and Natural Resources Office, City of Roxas.




