ORDINANCE NO. 020 - 2023

AN ORDINANCE AMENDING/SUPPLEMENTING ARTICLE 18 OF ORDINANCE NO. 033-2006, KNOWN AS "TRICYCLE FRANCHISING AND REGULATORY ORDINANCE", BY ADDING PARAGRAPH (g) TO THE EXISTING PARAGRAPHS (a) TO (f).

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of Roxas City that:

SECTION 1. - Article 18 of ORDINANCE NO. 033 - 2006 which read as follows:

Article 18 – Prohibited Acts – Acts prohibited particular to this Ordinance are enumerated with corresponding fines and penalty set forth:

PROHIBITED ACTS

a) For an operator or driver to operate or engage in the tricycle business or as private without a franchise or City Steel Plate Number.

1<sup>st</sup> Offense – Php 200.00
2<sup>nd</sup> Offense – Php 300.00
3<sup>rd</sup> Offense – Php 500.00
```

b) For an operator or driver to operate or drive a tricycle for hire without securing the necessary Mayor's Permit or without complying with any of the components thereof.

```
1<sup>st</sup> Offense – Php 200.00
2<sup>nd</sup> Offense – Php 300.00
3<sup>rd</sup> Offense – Php 500.00
```

c) For an operator or driver to display improperly or possess or have only one (1) city plate number attached to his tricycle or none at all.

```
1<sup>st</sup> Offense – Php 200.00
2<sup>nd</sup> Offense – Php 300.00
3<sup>rd</sup> Offense – Php 500.00
```

d) For a driver to load, or an operator who knowingly allows the use of the tricycle in the pursuit of illicit activities.

```
1<sup>st</sup> Offense – Php 200.00
2<sup>nd</sup> Offense – Php 300.00
3<sup>rd</sup> Offense – Php 500.00
```

e) For an operator or driver to attach, or allow the attachment of an accredited sidecar to a motorcycle not duly registered as a tricycle for hire, or of a duly registered motorcycle to a sidecar not accredited in accordance with this ordinance.

```
1st Offense – Php 200.00
2nd Offense – Php 300.00
3rd Offense – Php 500.00 plus impoundment of tricycle
```

f) Transfer of tricycle unit without registration:

Php 500.00 plus cancellation of franchise

Is hereby amended to read as follows:

Article 18 - Prohibited Acts - Acts prohibited particular to this Ordinance are enumerated with corresponding fines and penalty set forth:

PROHIBITED ACTS

a) For an operator or driver to operate or engage in the tricycle business or as private without a franchise or City Steel Plate Number.

1st Offense – Php 200.00 2nd Offense – Php 300.00 3rd Offense – Php 500.00 plus impoundment of tricycle

f) Transfer of tricycle unit without registration:

Php 500.00 plus cancellation of franchise

g) For an operator or driver to cover the City Number on the front and back of the motorized tricycle for hire:

1st Offense – Php 200.00 2nd Offense – Php 300.00 3rd Offense – Php 500.00

SECTION 2- Effectivity Clause – This Ordinance shall take effect five (5) days after posting in the conspicuous places in all Barangays and publication in a newspaper of local circulation in the City of Roxas for three consecutive weeks.
