ORDINANCE NO. 021 - 2023

AN ORDINANCE CREATING THE POSITIONS OF ONE (1) PARK MAINTENANCE GENERAL FOREMAN, SALARY GRADE 10, STEP 1, ITEM NO. 39 IN THE CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE AND TWO (2) TRAFFIC AIDE I, SALARY GRADE 3, STEP 1, ITEM NOS. 122 AND 123 IN THE CITY MAYOR'S OFFICE AND APPROPRIATING FUNDS THERETO.

WHEREAS, in his letter dated April 28, 2023, the City Mayor requested for the creation of One (1) Park Maintenance General Foreman, Salary Grade 10, Step 1, Item No. 39 in the City Environment and Natural Resources Office and Two (2) Traffic Aide I, Salary Grade 3, Step 1, Item Nos. 122 and 123 in the City Mayor's Office and appropriating funds thereto;

WHEREAS, Articles 3, Section 458 of the Local Government Code of 1991 provides that the Sangguniang Panlungsod as a legislative body of the city, shall (vii) subject to the provisions of this code and pertinent laws, determine the power and duties of officials and employees of the city; (viii) determine the position and salaries, wages, allowances, and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government;

WHEREAS, the creation of one (1) Park Maintenance General Foreman, Salary Grade 10, Step 1, Item No. 39 and Two (2) Traffic Aide I, Salary Grade 3, Step 1, Item Nos. 122 and 123 are deemed necessary in order that the existing vital programs and projects can be effectively managed and maintained with quality results.

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod, in session assembled and by authority of the same, that:

Section 1 - To create, as this Honorable Body hereby creates, the following positions:

1. One (1) Park Maintenance General Foreman, Salary Grade 10, Step 1, Item No. 39 City Environment and Natural Resource Office
2. Two (2) Traffic Aide 1, Salary Grade 3, Step 1, Item Nos. 122 and 123 City Mayor's Office

Section 2. Repealing Clause. All ordinances, resolutions, local executive orders and/or administrative regulations which are inconsistent or contrary to any of the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 3. – This Ordinance shall take effect upon approval.
