WHEREAS, on June 23, 2025, the Department of the Interior and Local Government issued Memorandum Circular No. 2025-060, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

WHEREAS, the **R.I.D 3850 Philippines Incorporated**, through its District Governor, Dr. Victor Federico B. Acepcion, has signified its intention to be an accredited CSO in the City of Roxas to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;

WHEREAS, the **R.I.D 3850 Philippines Incorporated** has satisfactorily complied with the requirements and criteria for accreditation as civil society organization in accordance with the procedures and guidelines set forth in DILG MC 2025-060;


NOW THEREFORE, on motion presented by Hon. Paul Ivan R. Baticados, unanimously seconded, it was
