RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, RONNIE T. DADIVAS, TO ENTER INTO AND SIGN, FOR AND ON BEHALF OF THE CITY OF ROXAS, THE MEMORANDUM OF AGREEMENT (MOA) WITH THE ROXAS CITY POLICE STATION RELATIVE TO THE MOTOR VEHICLES LOANED FOR USE TO THE ROXAS PNP BY THE ROXAS CITY GOVERNMENT

WHEREAS, in his letter dated January 29, 2026, Honorable City Mayor, Ronnie T. Dadivas, requested authority to enter into and sign, for and on behalf of the City of Roxas, a Memorandum of Agreement (MOA) with Roxas City Police Station relative to the motor vehicles loaned for use to Roxas PNP by the Roxas City Government;

WHEREAS, the City Government of Roxas recognizes the vital role of the Philippine National Police (PNP) in maintaining peace and order, ensuring public safety, and promoting the general welfare of the community;

WHEREAS, the Roxas City Police Station does not possess enough vehicles and in dire need of such asset for the effective accomplishment of its assigned tasks;

WHEREAS, the City Government of Roxas is the registered owner of two (2) motor vehicles and four (4) motorcycles intended to be loaned for official police use, particularly described as follows:
