RESOLUTION NO. 026 – 2026

RESOLUTION AUTHORIZING THE CITY MAYOR’S OFFICE TO ISSUE A PERMIT FOR TEMPORARY EXEMPTION FROM TRUCK BAN EMBODIED IN ORDINANCE 003-2005, AS AMENDED, TO THE CAPIZ COMMERCIAL SCHOOL FROM FEBRUARY 16, 2026 TO FEBRUARY 25, 2026.

WHEREAS, in his letter dated January 29, 2026, the City Mayor forwarded the request of Mr. Sing Sim Simyon Y. See, Head –Chinese Department, Capiz Commercial School, for temporarily exemption from truck ban ordinance on February 16, 2026 to February 25, 2026 in celebration of the Chinese New Year, for appropriate action;

WHEREAS, Dragon and Lion Dance is an important part in the celebration of Chinese New Year, it is believed that dragon and lion represent prowess, nobility and fortune, drive out evils and bring good luck;

WHEREAS, a one (1) unit six-wheeler truck will be used to transport dancers and equipment to different location in the city;

WHEREAS, exempting one (1) unit six-wheeler truck of the Capiz Commercial School will contribute to the success of the celebration of the Chinese New Year.

NOW THEREFORE, on motion presented by Hon. Fernando Luis A. Viterbo, unanimously seconded, it was

RESOLVED, to authorize, as this Honorable Body hereby authorizes, the City Mayor’s Office to issue a permit for temporary exemption from truck ban embodied in Ordinance 003-2005, as amended, to the Capiz Commercial School from February 16, 2026 to February 25, 2026.

RESOLVED FURTHER, that this exemption does not include or apply to truck ban embodied in Ordinance No. 035-2025.
