RESOLUTION NO. 027 – 2026

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, RONNIE T. DADIVAS, TO ENTER INTO AND SIGN, FOR AND ON BEHALF OF THE CITY GOVERNMENT OF ROXAS, THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT OFFICE (DSWD) - FIELD OFFICE VI, RELATIVE TO THE REHABILITATION AND AFTERCARE SUPPORT OF CHILDREN IN CONFLICT WITH THE LAW (CICL).

WHEREAS, in his letter dated February 6, 2026, the City Mayor requested for the passage of a resolution authorizing him to enter into and sign, for and on behalf of the City Government of Roxas, the Memorandum of Agreement (MOA) with the Department of Social Welfare and Development Office (DSWD) - Field Office VI, in relation to the rehabilitation and aftercare of Children in Conflict with the Law (CICL);

WHEREAS, the DSWD is the lead government agency responsible for developing and implementing social welfare and protection programs to uplift and empower the poor, vulnerable, and disadvantaged sectors, in partnership with Local Government Units (LGUs), People's Organizations (POs), Government Organizations (GOs), and other civic organizations;

WHEREAS, the said agency operates as a residential care facility providing 24-hour group living services on a temporary basis. It serves as a nurturing out-of-home placement designed to deliver intensive treatment for the rehabilitation of CICL whose sentence have been suspended;

WHEREAS, the Local Government of Roxas City is the primary government agency responsible for ensuring the welfare of all people residing within its territorial and political subdivision through the provision of quality basic services and proper implementation of ordinances, rules and regulations in accordance with the existing laws of the Philippines;

WHEREAS, the said LGU plays a key role in ensuring the successful reintegration of CICL into the community through participation in pre-discharge conferences and aftercare planning;

WHEREAS, Section 455(1)(vi) of the Local Government Code of 1991, provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and, such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;
