RESOLUTION NO. 028 – 2026

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, RONNIE T. DADIVAS, TO ENTER INTO AND SIGN, FOR AND ON BEHALF OF THE CITY GOVERNMENT OF ROXAS, THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) - FIELD OFFICE VI, RELATIVE TO THE IMPLEMENTATION OF THE ASSISTANCE TO INDIVIDUALS AND FAMILIES IN CRISIS SITUATION (AICS) PROGRAM AND AYUDA PARA SA KAPOS ANG KITA PROGRAM (AKAP) IN THE MAXIMUM ALLOWABLE AMOUNT AND ALL OTHER SUBSEQUENT TRANCHES THROUGH THE TRANSFER OF FUNDS (TOF) MODALITY.

WHEREAS, in his letter dated February 6, 2026, the City Mayor requested for the passage of a resolution authorizing him to enter and sign, for and on behalf of the City Government of Roxas, the Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) - Field Office VI, relative to the implementation of the Assistance To Individuals and Families In Crisis Situation (AICS) Program and Ayuda para sa Kapos ang Kita Program (AKAP) in the maximum allowable amount and all other subsequent tranches through the Transfer of Funds (TOF) modality;

WHEREAS, the DSWD, pursuant to Executive Order (EO) No. 221, series of 2003 and EO No. 137, 2021, implements crisis intervention, through the Assistance to Individuals and Families in Crisis Situation (AICS) program;

WHEREAS, DSWD issued Memorandum Circular (MC) No. 16, s. 2022 entitled "Revised Guidelines for the Implementation of the Assistance to the Individuals and Families in Crisis Situation which provides for the different modes of disbursement strategies, such as transfer of funds to local government units;

WHEREAS, pursuant to Republic Act (RA) No. 7160, otherwise known as the Local Government Code of 1991, the Local Government Units (LGUs) are mandated to promote the general welfare of their constituents and are empowered to enter into cooperative arrangements with national government agencies (NGAs) to effectively deliver basic services and implement social welfare programs within their respective jurisdictions

WHEREAS, the Roxas City LGU are mandated by law to discharge basic services, including social welfare services to its constituents;

WHEREAS, Section 455(1)(vi) of the Local Government Code of 1991, provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and, such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW THEREFORE, on motion presented by Hon. Reynaldo C. Magallanes and Hon. Paul Ivan R. Baticados, unanimously seconded, it was

RESOLVED: To authorize, as this August Body hereby authorizes, the Honorable City Mayor, to enter into and sign, for and on behalf of the City Government of Roxas, the Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) Field Office VI, relative to the implementation of the Assistance To Individuals And Families In Crisis Situation (AICS) Program and Ayuda Para sa Kapos ang Kita Program (AKAP) in the maximum allowable amount and all other subsequent tranches through the Transfer of Funds (TOF) modality.
