RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, RONNIE T. DADIVAS, TO ACCEPT AND SIGN, FOR AND ON BEHALF OF THE CITY GOVERNMENT OF ROXAS, THE DEED OF DONATION (DOD) MADE AND EXECUTED BY THE OFFICE OF THE PRESIDENT (OP) IN FAVOR OF THE CITY GOVERNMENT OF ROXAS, INVOLVING THE SPECIAL FINANCIAL ASSISTANCE (SFA) IN THE AMOUNT OF TEN MILLION PESOS (₱10,000,000.00) UNDER ITS SOCIO-CIVIC PROJECTS FUND (SCPF).

WHEREAS, in his letter dated 16 February 2026, the Honorable City Mayor, Ronnie T. Dadivas requested for authority to accept the donation, on behalf of the City Government of Roxas, involving the Special Financial Assistance in the amount of Ten Million Pesos (P10, 000,000.00) from the Office of the President under Socio-Civic Projects Fund (SCPF) intended for families severely affected by flooding caused by Tropical Storm Ramil, and to enter into and sign the corresponding Deed of Donation and all related documents necessary for its implementation;

WHEREAS, the Office of the President (OP) represented by Senior Deputy Executive Secretary Maria Luwalhati C. Dorotan Tiuseco recognizes the necessity of extending immediate financial assistance to support the Roxas City Government in addressing the needs of affected families and facilitating the recovery and rehabilitation of communities due to the aftermath of the said tropical storm;

WHEREAS, the Office of the President (OP) has manifested its intent to donate to the City Government of Roxas a Special Financial Assistance (SFA) in the amount of Ten Million Pesos (₱10,000,000.00), sourced from its Socio-Civic Projects Fund (SCPF) by virtue of OP Office Order No. 02 dated 29 December 2016, and approved Memorandum for the Executive Secretary dated 11 November 2025;

WHEREAS, the grant of the donation requires the execution and signing of a Deed of Donation (DOD) by the Local Chief Executive of the City Government of Roxas;

WHEREAS, the City Government of Roxas hereby accepts the donation and expresses its appreciation and gratefulness for the support of the National Government;

WHEREAS, the Roxas City LGU is the primary government agency responsible for ensuring the welfare of all people residing within its territorial and political subdivision through the provision of quality basic services and proper implementation of ordinances, rules and regulations in accordance with the existing laws of the Philippines;

WHEREAS, Section 455(1)(vi) of the Local Government Code of 1991, provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and, such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;
