RESOLUTION RESPECTFULLY ENDORSING TO THE HONORABLE JUANITO VICTOR C. REMULLA, JR., SECRETARY OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), THE REQUEST OF HONORABLE CITY MAYOR, RONNIE T. DADIVAS FOR FINANCIAL ASSISTANCE RELATIVE TO THE IMPROVEMENT/REHABILITATION OF THE BJMP VISITATION AREA AND ROOF DECK ROOFING, LOCATED AT BARANGAY SAN JOSE, ROXAS CITY.

WHEREAS, in his letter dated March 2, 2026, Honorable City Mayor Ronnie T. Dadivas, requested the passage of a resolution endorsing the request for financial assistance from the Department of the Interior and Local Government (DILG), for the improvement/rehabilitation of the BJMP Visitation Area and Roof Deck Roofing, located at Barangay San Jose, Roxas City;

WHEREAS, the requested financial assistance in the amount of Two Million Four Hundred Thousand Pesos (Php 2,400,000.00) shall be allocated for the improvement and rehabilitation of the BJMP Visitation Area and Roof Deck Roofing in order to enhance safety, security, and overall facility conditions;

WHEREAS, Roxas City's local jail facility currently houses a significant number of Persons Deprived of Liberty (PDLs), resulting in severe congestion and inadequate living conditions;

WHEREAS, in order to comply with the mandates of the Bureau of Jail Management and Penology (BJMP) concerning secure, clean, and safe facilities, the said improvements are urgently needed;

WHEREAS, the Roxas City Government is the primary government agency responsible for ensuring the welfare of all persons within its territorial jurisdiction through the provision of basic quality services and the proper implementation of ordinances, rules, and regulations in accordance with existing laws of the Philippines;
